

Alternative views of World War II

What if? That's the question that drives almost all fiction. Authors wonder what would happen if a person fell in love or moved halfway across the world or just decided to drive by a different route to work one day. However, another version of this question serves as the impetus for the alternative history genre. For example, what if the South won the Civil War? What if technology were more advanced during the French revolution? What if someone used time travel to prevent John F. Kennedy from being assassinated? Some of these stories stray into fantasy or science fiction, but not all. Two recent works of alternative history try very hard to adhere to historical reality – except for one or two vital changes. While Guy Saville's "The Madagaskar Plan" (Henry Holtand Company) posits a world where Nazi Germany transported European Jews to Madagascar, an island off the coast of Africa, rather then sending them to concentration camps, "The Ambassador" by Yehuda Avner and Matt Rees ((The Toby Press) suggests what might have occurred if Israel became a state in 1937, rather than in 1948.

"The Madagaskar Plan" opens in 1952 to a world where Great Britain and Germany signed a peace agreement af-

people from all walks of life – different nationalities [and] religions – that came for one purpose: humanitarian aid."

By giving the presentation, she hopes to help spread awareness of the problems, clear up misconceptions and potentially inspire more volunteerism. "I think people will be more aware of what is really happening [and] they could maybe contribute or their perspective will change, she said. "I'm in hope people will see things as they are, not as they're portrayed in the media." She admitted that her idea to actually volunteer to work in Greece was unusual. "I wouldn't expect people to go and take a plane and fly to Greece or fly to Europe and help refugees," she said. "I think it's a big leap that I took. But I'd like to see people more engaged in this, or that people will donate or understand the crisis... If people can help in any way that would be great, but if you don't have the means to help or do something about it, just spread the word out there and understand better the situation.'

ter the Germans destroyed British forces at Dunkirk. (In real life, most of the troops were successfully evacuated.) Although the British empire and Nazi Germany divided most of Africa between the two countries, tensions remain as each side jockeys for power. The United States has remained strictly isolationist during these events, although American Jews are pressuring the government about the Nazis treatment of the Jews in Madagascar. (In real life, the Nazis considered making Madagascar a Jewish settlement before deciding the plan wasn't feasible.) Since "The Madagaskar Plan" is the second book in "The Afrika Reich" trilogy, this information is given in the opening pages so readers (like myself) who haven't read the first novel will be able to follow the action.

The plot centers on conflicting British and Nazi plans for Africa. Although technically not at war, each vies for control of the continent. At the same time, the Nazis seek a final solution to the Jewish problem, even as they pretend the island of Madagascar will be a new homeland for the Jews, rather than a place to die. The British want to help the emerging Jewish resistence effort and blackmail Reuben Salois, one of the only Jews ever to escape from Madagascar, to return and lead the rebellion. Salois hopes his effort will force the U.S. to declare war on Germany so the Nazis can be defeated. British mercenary Burton Cole, on the other hand, travels to Madagascar for personal reasons: to rescue his Jewish lover, Madelene Cranley, whose British husband sent her to the island as a punishment for infidelity. Several Nazis also play an important role in the action, including Obergruppenführer Walter Hochburg, who seeks Cole's death for reasons based on their common past. The wide-ranging cast of characters – British, German and Jewish – all have conflicting agendas.

While "The Madagaskar Plan" veers greatly from recorded history, "The Ambassador" hews closer to reality. What does change is British actions in the Middle East: after English troops leave Palestine, the League of Nation votes to create the state of Israel in 1937. When Israel wins its War of Independence (like the state did in 1948), David Ben Gurion – who, as in real life, was elected as Israel's first prime minister – appoints Dan Lavi as its ambassador to Berlin before the formal start of World War II. Lavi's mandate is to help as many Jews as possible escape from

Germany. In order to get permission for these Jews to leave, he must work with high level Nazi officials whose contempt for him and Israel is obvious. His position is controversial – both at home and in Europe. Will he be accused of fraternizing with Nazis – wasting his time while they plan the destruction of the European Jewish community? Should he support Mossad, whose members want to assassinate Hitler? As events progress, Lavi must decide the best path to help his country and his people. The question becomes whether or not saving the lives of others will come at great personal expense.

While it would have been interesting to read either of these novels on their own, reading them together was a fascinating experience. One or two changes in historical fact created very difference worlds, something that is the underlying basis of the alternative history genre. Although the focus of "The Ambassador" is on Jewish history, the reality of the Nazis' hatred of Jews is also clearly shown in "The Madagaskar Plan." The range of the novels also differs. This is mainly due to plot considerations: "The Madagaskar Plan" is set across parts of England and Africa. The majority of "The Ambassador" occurs in Berlin, although some action is located in Israel. Both works contain a multitude of characters – some well-rounded and others more stereotypical. However, since the emphases in both is on plot rather than character development, that didn't distract from my enjoyment.

These novels are aimed at fans of alternative histories, although they will also appeal to readers of action novels. "The Madagaskar Plan" is the more difficult to read due to its dense, rich prose and its many descriptions of place - particularly in those sections taking place in Africa – which also makes it the more literary work. "The Ambassador" moves faster due to fewer descriptions and more dialogue. While I didn't feel much emotional response during the course of either book, I was surprised by my reaction to their endings. "The Madagaskar Plan" made me understand the deep feeling of revenge that has to be the focus of book three in the series, while the epilogue of "The Ambassador" brought tears to my eyes. It's difficult to recommend one over the other because it depends on one's personal preference. However, reading them together gave me far more to contemplate about the nature of history than reading either alone.
